Since December 2014 ASLA Leadership has visited 18 states, 12 chapters and 14 student chapters.

Purpose: To provide a summary of recent accomplishments across major program areas.

Highlights:

"The Landscape Report" produced by Landscape Architecture Magazine and emailed to members twice weekly.

BOT approved ASLA participation in the UN Global Compact (Separate Document). The Global Compact offers a policy framework for the development, implementation and disclosure of sustainability principles and practices related to its four core areas: human rights, labour, the environment and anti-corruption.

BOT approved a Joint Statement on Diversity for the landscape architecture profession (Separate Document).

"The undersigned organizations hereby make a commitment to increase resources and actions that recruit minority students to landscape architecture programs and help mentor graduates through licensure and their careers".

- Assets increased in 2014 by \$800,000.
- Denver Annual Meeting revenue \$4.2 million. Second highest in history.
- Annual revenue LAM 26%. Meetings 35%. Membership 30%

- Fundraising packet being created for use in further donation solicitation (general membership and friends of the profession.

BOT approved increasing maximum mortgage amount from \$3 million to \$4 million, and construction loan from \$4 million to \$5.5 million.
